

Documentation for an RN moving into a practitioner role can be daunting especially for me with 30+ years of charting in a nurse role. This book is a nice reference for a variety of clinical areas; acute care and primary care. I am glad I found it and am happy with the examples provided as I move into thinking and charting as a mid-level provider.

Easy-to-read, informative text. Enjoy that there are worksheets at the end of each chapter as well as other questions throughout the chapter to "test" your knowledge of material read. I believe this book will be a "keeper" as there is a lot of information to refer back to as I progress through my NP

program.

This was a required text for my NP program. I was impressed with the amount of information this author supplied in this book. It is definitely a keeper. I would recommend this product to other health care professionals.

Right down to it charting instructions and guidance. Even discusses codes and other factors of charting I had not taken into such deep account before. My focus was learning the SOAP note, this book helped me understand how much more charting, other than SOAP's, must be completed for compliance standards. There were some areas I found elementary, simply because I already knew of them; however, other 'elementary areas' I had never considered before. I feel this book is for just about everyone who is learning to chart as a reimbursable provider. Every nickel counts. I believe this book teaches well, how to capture reimbursement by complete charting.

Informative book, however written a little poorly. A bit confusing layout and hierarchy of the material presented in each chapter. The language used is adequate to convey the material for one to grasp easily. However the question and answer sections need to be rethought. It does not sufficiently gauge what was learned in the chapter. It feels more like busy work. Nothing is explained clearly in the answers section. A little difficult to learn from mistakes without going back through the chapters and wasting time. Overall I would definitely recommend this text even if it not required by your program. It can be a great supplement.

Extremely useful book. It is good for RNs who are looking for a job or already work on a medical floor in a hospital. The book is perfect source of information for those who do medical records, progress notes, SOAP notes, etc. The book must have all medical facilities.

Certain sections such as immunizations offer helpful information. The H&P is a stumbling point of this text as it left areas of the family hx and ROS incomplete. Use it in addition to your textbook.

This book was okay. It was a bit dry and kind of boring, but I guess this isn't the most exciting topic. It's a nice reference but if you have access to an online search engine (and I'm guessing you do!) you can find most of the information online. Skip it unless you prefer an actual book.
